2. In Pench Diversion Project (W.O. No 643/SAA/ II/2013-14 dated 13.5.2013, W.O. No. 1013/SAC dated 24.7.2013, W.O. No. 1112/SAAD/2013-14 dated 08.8.2013, W.O. No. 1116/SAC, dated 08.08.2013) and in Mahi Dam Project (Work Order No. 2245/SAC/2013-14 dated 03.10.13, 151/2013-14/E-in-C/e-tendering dated 22.07.13 and 04/OCN/2013-14 dated 05.11.13), whether contractor obtained permission of competent authority for subletting the works? Copy of authorization letter may be provided, if any, in support of reply.
3. Kindly intimate all the cases in the Madhya Pradesh where 100 per cent work has been sublet to subcontractors.
4. In case, 100 per cent work sublet is not authorized, kindly intimate the action taken in such cases where 100 per cent work has been sublet.
